**Detroit, MI — The people of Detroit are being asked to watch closely as the fight for fair Elections takes center stage for round 2 Monday as Dustin Campbell v. City of Detroit Department of Elections reaches a critical juncture. An emergency hearing has been filed challenging his disqualification from the ballot based on a decade-old technicality. The hearing is set for Monday, April 21, 2025, at 9:00 AM at Wayne County's 3<sup>rd</sup> Judicial Circuit Court.**

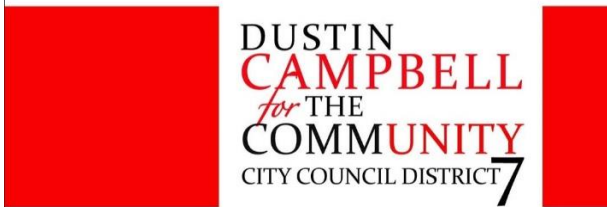

**Dustin Campbell is not asking for special treatment. He submitted all 300 required signatures and has complied with the law. This is about acknowledging an error, not excusing wrongdoing. Will the Committee act with integrity and correct its own record?**

**This is not just an election technicality — it's a constitutional issue. The right to run for office is protected under the First and Fourteenth Amendments. If the courts side with transparency, due process, and reason, it will be a powerful affirmation that the everyday citizen still has a voice.**

#### **❖ Why This Matters — For Detroit and the Nation**

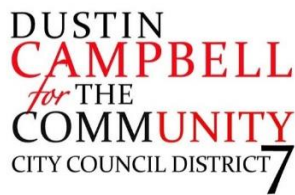
